
WHEN: SEPTEMBER 2, 2019 AT 3:00 PM (MONDAY)

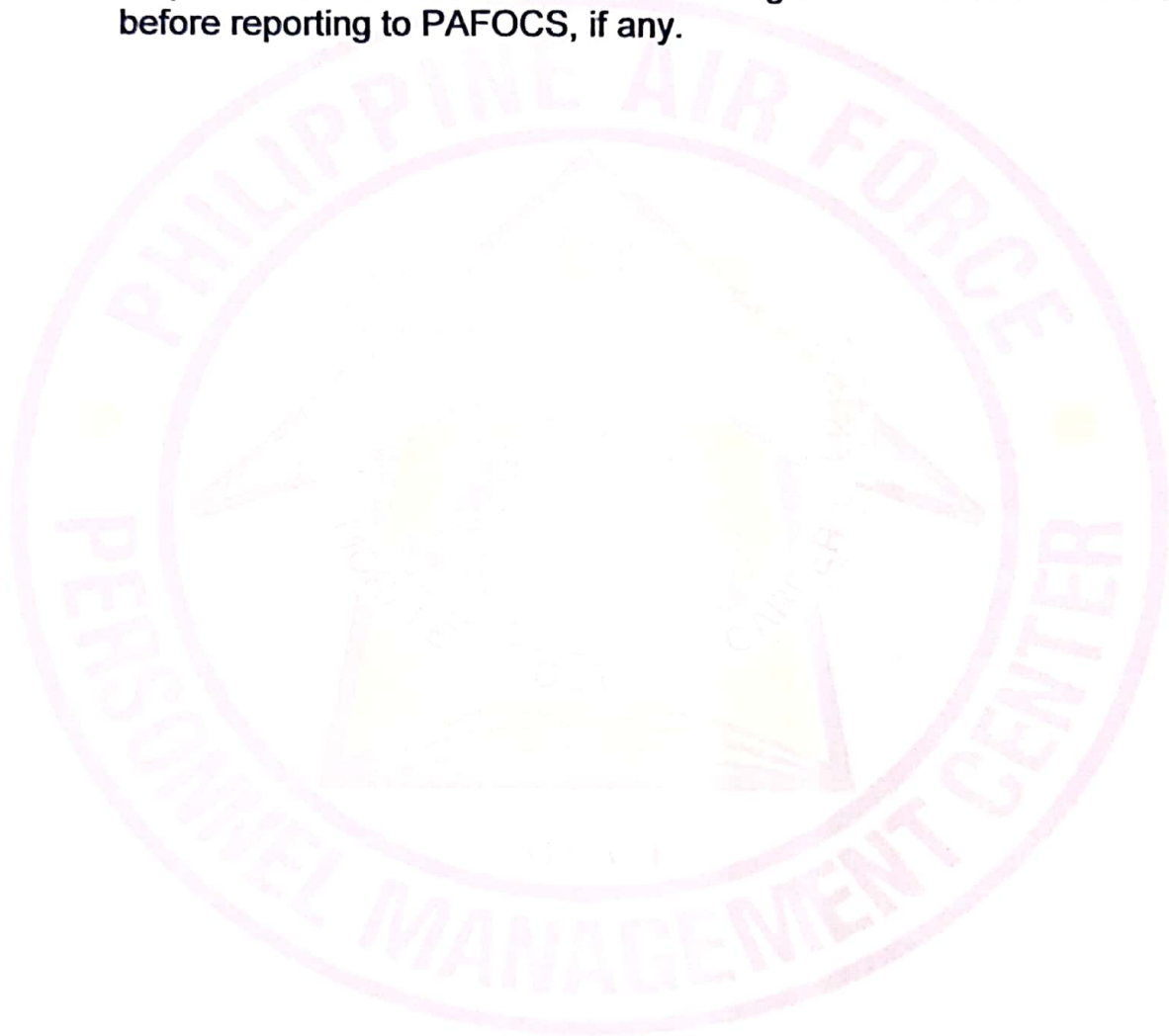




